

## **Samaritan House Transitional Housing Program Agreement**

I, \_\_\_\_\_, agree to participate in the Samaritan House Transitional Housing Program. During my stay in the Program, I will abide by the rules of the house, as stated below. I agree to follow the rules and guidelines as outline in this agreement. I understand if I break any of the rules I may be asked to leave immediately.

In addition, I agree to meet with my case manager weekly and to follow the initial attached service plan and all subsequent contracts and plans developed with my case manager.

I understand that I am expected to pay a program fee of \$\_\_\_\_ a week. I will pay this every Monday to the Samaritan House Director or Program Coordinator.

Rules of Samaritan House (Violation of any of these rules could lead to immediate termination from the program.)

1. Samaritan House is Drug and Alcohol Free. You cannot use or possess alcohol or drugs on or around the premises. You cannot abuse prescription drugs at Samaritan House. Entering the premises with alcohol or drugs in your system is prohibited. Individual service plans may be more restrictive concerning your alcohol and drug use, if warranted. If you do not follow your individual plan, you will be asked to leave.
2. Physical and/or verbally threatening or violent behavior towards others is prohibited in Samaritan House.
3. Weapons are strictly prohibited on the premises
4. Rooms must be clean and sanitary at all times. The Program Coordinator or Support Workers will carry out weekly room checks. Room checks will occur even if you are not in the building.
5. Smoking is not permitted anywhere in building including the bedrooms.
6. Behavior that interferes with the health, safety or peaceful enjoyment of the premises is prohibited.
7. Intolerant behavior towards others is prohibited. This includes discriminatory speech or acts based on differences in gender, race, class, and religion sexual orientation and or physical or mental level of ability.

8. Drug related criminal activity on or off the premises is prohibited
9. Criminal activity of any type is prohibited on the premises
10. The program fee must be paid in full every Monday of every week.
11. Visitors must be accompanied by you at all times. Visitors are not allowed onto the premises, including the porch and steps, when you are not with them.
12. Intoxicated visitors are never allowed in or around the premises
13. All visitors must leave the premises by 10:00 pm and cannot return until 8 am. No overnight visitors are allowed. No one can ever be allowed to share your room at any time. Visitors must be respectful of other Program participants.
14. No minors are allowed on the premises at any time unless you receive prior approval from the Executive Director. You may not have any pets while staying at Samaritan House.
16. Destruction of Samaritan House property is prohibited. You will be required to pay for any and all damage done to the property.
17. Individual service plans must be followed in order to remain in the Program.
18. You must ask permission from the Program Coordinator or his/her designee if you are planning to spend the night out.
19. Once you leave the Housing Program, you will have two weeks to remove items left behind.
